The Honorable Cristian M. Stevens, Missouri Court of Appeals, Eastern District

Judge Stevens was appointed to the Missouri Court of Appeals in 2021. He is a graduate of the University of Missouri-Columbia (magna cum laude) and the University of Missouri-Columbia School of Law (cum laude). Prior to his appointment to the Court of Appeals, Judge Stevens worked in private practice, served as Assistant United States Attorney at the United States Attorney's Office for the Eastern District of Missouri from 2002-2017, and was First Assistant Attorney General and Deputy Attorney General for the Criminal Division of the Missouri Attorney General's Office from 2019-2021.
